**EAGLE ENERGY TRUST CONFIRMS
JUNE 2011 DISTRIBUTION**

Calgary, Alberta – June 15, 2011 – **Eagle Energy Trust (TSX:EGL.UN)** confirms that the cash distribution to be paid on July 22, 2011, in respect of the period from and including June 1, 2011 to June 30, 2011, for unitholders of record on June 30, 2011 will be \$0.0875 per trust unit. The ex-distribution date is June 28, 2011.

The annualized distribution of \$1.05 per trust unit represents a cash-on-cash yield of approximately 9.6% based on the closing price of our trust units on the Toronto Stock Exchange on June 14, 2011 of \$10.95.¹

Eagle is an oil and gas energy trust created to provide investors with a publicly traded, oil and natural gas focused, distribution producing investment, with favourable tax treatment relative to taxable Canadian corporations.
