**EAGLE ENERGY TRUST CONFIRMS
AUGUST 2011 DISTRIBUTION**

Calgary, Alberta – August 15, 2011 – **Eagle Energy Trust (TSX:EGL.UN)** confirms that the cash distribution to be paid on September 23, 2011, in respect of the period from and including August 1, 2011 to August 31, 2011, for unitholders of record on August 31, 2011 will be \$0.0875 per trust unit. The ex-distribution date is August 29, 2011.

The annualized distribution of \$1.05 per trust unit represents a cash-on-cash yield of approximately 10% based on the closing price of our trust units on the Toronto Stock Exchange on August 12, 2011 of \$ 10.35.¹

Eagle is an oil and gas energy trust created to provide investors with a publicly traded, oil and natural gas focused, distribution producing investment, with favourable tax treatment relative to taxable Canadian corporations.
